The Sweepstake is open only to those legal residents of Ontario, Canada, who are 19 years of age or older as of the date of entry and who meet the eligibility requirements. Sponsor

How To Enter

Participants may enter the Gin & Sonic Giveaway via Instagram.

To enter via Instagram:

As a registered Instagram Account holder, participants must follow @ginsonic on Instagram, like the image of the Sweepstakes, and comment on the sweepstakes photo by tagging up to six (6) friends (separate accounts) in up to six (6) separate comments. One (1) tag per comment. One (1) entry per tag per participant. At the conclusion of the sweepstakes, @ginsonic will contact the prize winner.

We reserve the right to delete any comments, for any reason. Entries cannot defame, misrepresent or contain disparaging remarks about Sponsor or any of its products, or other people, products or companies or communicate messages or images inconsistent with the positive images and/or goodwill to which Sponsor associates. Sponsor reserves the right to monitor and will monitor or screen entries and delete, if required in its sole discretion. Any such entrant will indemnify and hold harmless, Sponsor and Promotion Entities from any claims to the contrary. Prize(s)

The winner will be randomly selected from all eligible entries to win one (1) Ooni pizza oven. Approximate total value of the prize to be awarded is \$400 CAD per prize.

Winner Selection

Potential winner will be notified by Instagram Direct Message and will be required to correctly answer an unaided, time-limited, mathematical skill-testing question.

The potential winner will be required to respond to the notification within one (1) day. The potential winner may be required to execute an Affidavit of Eligibility and Liability/Publicity Release form ("Eligibility/Liability Form") within two (2) days of notification or the prize will be forfeited and an alternate winner will be randomly selected from all eligible entries received.
